## Message from the President

We are pleased to present this year's Annual Report for the United Way of Kent County. Our Fiscal Year runs from September 1 to August 31. In our 2019-2020 campaign, we set our fundraising goal at \$235,000, and we are pleased to report that once again, our generous contributors exceeded our goal.

To begin with, we knew \$235,000 was a lofty goal. (\$10,000 more than the last year's campaign.) And with all the complications we have faced this spring, we were more than a little worried if we would make it. Our donors rose to the occasion! United Way of Kent County and the citizens of Kent County thank you. Most of all, the Agencies who are the ultimate recipients of those funds thank you. We list most of our loyal and generous donors in the pages that follow. You should be proud to see your name.

Much like 1918 was the year of the Spanish Flu, 2020 will forever be the year of the COVID-19 pandemic. This year we all need to pitch in to help, and your United Way of Kent County's small part was to grant **\$10,000** so far in emergency COVID-19 requests. Our grants were in addition to our regular support of Kent County charities. In addition to the COVID-19 money, we granted allocations to 23 different 501(c)3 Agencies for the valuable work they do in Kent County.

Going forward, we worry about the economic effect of COVID-19 on our employer-based campaigns. Much of our funds come from workplace donations through payroll deductions. And we all know the devastating impact the virus has had on our local businesses. They are struggling through the closings, sick employees, and disrupted supply chains. Yet the needs of our charitable organizations, and the community services they provide, has grown.

As a result, we have set the 2020-2021 annual goal at **\$245,000**. Again, maybe a bit lofty, but goals are supposed to be inspirational. When times are difficult, we already know Kent County residents help one another. This year we will be asking for our donors to reach a little deeper to help us help our charities. 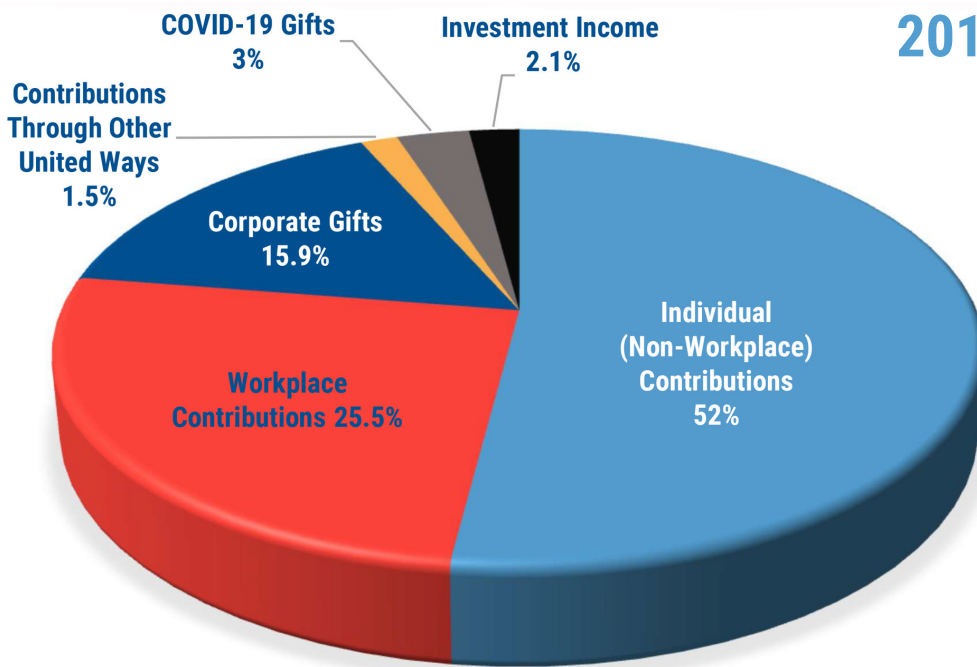

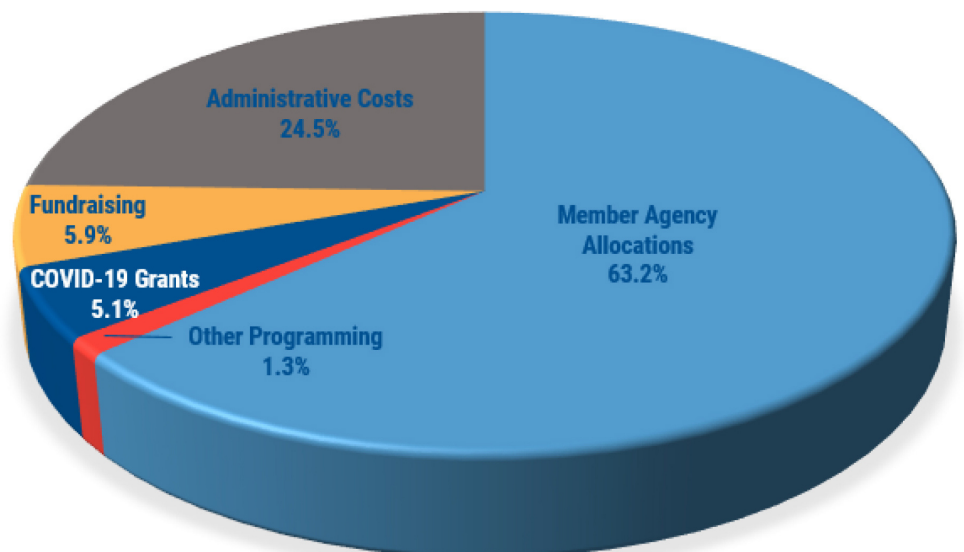
